The program Humble ISD would like to implement with grant funds is Newsela Social Studies and Newsela Writing. Newsela is an innovative, digital instructional platform designed to transform students' engagement with Social Studies and Writing. By offering high-interest, standards-aligned content, Newsela supports educators in delivering differentiated instruction that meets the diverse needs of today's classrooms. Equipping secondary students and educators with high-quality, aligned instructional resources that foster academic growth aligns with the Humble ISD mission statement, "Our purpose, in partnership with families and community, is to develop each child intellectually, artistically, emotionally, physically, and socially so that all students are life-long learners, complex thinkers, responsible global citizens and effective communicators." Currently, Humble ISD faces a significant gap in the availability of secondary cohesive, teacher-friendly materials that effectively support instructional goals. To address this need, the district seeks resources that: (a) align with the Texas Essential Knowledge and Skills (TEKS) standards for United States History, Texas History, and English Language Arts, ensuring consistency and rigor across grade levels; (b) provide robust tools to monitor and track the progress of each individual student, enabling data-driven instruction and targeted interventions;

By securing such resources, Humble ISD aims to empower educators, enhance student learning outcomes, and ensure alignment with state standards across key subject areas. A subscription to Newsela Social Studies and Newsela Writing will help us achieve our mission because the Social Studies platform provides a wide array of articles and primary sources curated to meet TEKS standards, including the Texas State History Collection and U.S. History content. Each article is leveled for differentiated learning and includes aligned quizzes and lesson sparks to deepen understanding. The Writing platform complements the Social Studies curriculum by embedding writing prompts and performance tasks that develop critical thinking and writing skills tailored to TEKS standards.

E. Budget Narrative

The proposed budget of \$289,080 is strategically allocated to directly support both students and teachers, aligning with the program's primary goal of improving student outcomes in Social Studies and Writing (ELA). The majority of the budget, \$277,680, is dedicated to purchasing a two-year subscription to Newsela's resources for all students in: 7th Grade Texas History, 8th Grade U.S. History, 11th Grade U.S. History, all lead-in History courses including 6th, 9th, and 10th Grade Social Studies Courses, and 6-E2 English Language Arts (ELA) Writing Courses. This represents approximately 22,250 students. Each year, the Newsela subscriptions cost \$6.24 per student (\$4.24 for Social Studies and \$2 for Writing). Therefore, a two-year subscription to both of those platforms costs $\$6.24 \times 2 \text{ years} = \$12.48/\text{per student} \times 22,250 \text{ students} = \$277,680$. The remainder of the budget, \$11,400, will be allocated to a two-year contract with Newsela to deliver one in-person personal development training and two virtual personal development trainings per year for teachers. Each in-person training is \$4,200 and each virtual training is \$750. Therefore, $\$4,200 \times 2 \text{ sessions} + \$750 \times 4 \text{ sessions} = \$11,400$. This budget of \$289,080 would have an additional \$10,537 added for indirect costs bringing the total budget to \$299,617.

Humble ISD will provide all necessary supplies or resources for the program's implementation, ensuring that the budget remains focused on direct instructional support.

Currently, no funds are allocated to a similar program. Secondary campuses rely on outdated materials from the last instructional resource adoption cycle, which do not fully align with current state standards or instructional best practices.

As the program is implemented, the district will monitor its effectiveness through student performance data and teacher feedback. If the resources positively impact student outcomes, the district will utilize this data to make informed decisions about establishing an ongoing allocation of funds. This will ensure the continuation and potential expansion of the program in future academic years without interruption.

Humble ISD will extend this opportunity to all teachers responsible for teaching the identified courses. Given the absence of a current, aligned curriculum, Newsela will serve as the primary instructional resource for these courses. While teachers will have autonomy in how they implement the resources to best meet the needs of their students, they will receive comprehensive support to ensure effective usage. This includes a district-provided scope and sequence aligned with state standards to guide instructional planning; embedded assessments to track student progress and inform instructional adjustments; professional development sessions to ensure teachers are confident and proficient in utilizing the platform, and ongoing support from Instructional Coaches. To foster teacher commitment, Humble ISD will integrate Newsela as the expected curriculum for the targeted courses, ensuring its use is embedded into daily instruction. However, recognizing the importance of teacher autonomy, educators will retain the flexibility to customize how they incorporate Newsela into their lessons, promoting a sense of ownership and engagement. By combining structured support with instructional flexibility, Humble ISD will ensure high levels of teacher engagement and successful program implementation.

2. Describe how the LEA will ensure successful cross-curricular implementation of the program in each of the 2025-2026 and 2026-2027 school years.

To ensure successful cross-curricular implementation of the program in both the 2025-2026 and 2026-2027 school years, the LEA will leverage a Trainer-of-Trainers (ToT) model using our Instructional Coaches in both Social Studies and English Language Arts (ELA). These coaches will receive in-depth training on the integration of Newsela resources, with a specific focus on cross-curricular instructional strategies. The trained coaches will then deliver professional development sessions to teachers in their respective content areas, focusing on effective methods for incorporating Newsela into their daily instruction to promote literacy and critical thinking skills across disciplines. This will foster consistency and alignment in cross-curricular practices across the district. To maintain momentum and ensure fidelity of implementation, we will hold regular meetings every five weeks with the instructional coaches. These meetings will serve as checkpoints to: review progress and address challenges, share best practices and success stories from classrooms, refine training approaches based on feedback, and ensure alignment with curriculum goals and standards. Through this structured support and ongoing collaboration, we will ensure that the cross-curricular use of Newsela is effectively integrated and sustained across both school years.

These tools are selected for their robust alignment with the Texas Essential Knowledge and Skills (TEKS) standards and their capacity to integrate English language arts (ELA) with historical content. Newsela Social Studies provides many articles and primary sources curated to meet TEKS standards, including the Texas State History Collection and U.S. History content. Each article is leveled for differentiated learning and includes aligned quizzes and lesson sparks to deepen understanding. Newsela Writing complements the Social Studies curriculum by embedding writing prompts and performance tasks that develop critical thinking and writing skills tailored to TEKS standards.

The LEA will implement the interactive online learning models in the following history classes:

Transcripts accompanying videos allow students to follow along and deepen their understanding. These writing activities are aligned with TEKS and foster skill development in both English and Spanish. Teachers can assign the same articles in both English and Spanish based on individual language proficiency, which allows Spanish-speaking students to begin engaging with articles and writing prompts in their native language while ensuring all students have access to meaningful content and skill development.
