The San Marcos CISD Teaching and Training Program of Study aims to build a sustainable teacher pipeline by inspiring and preparing high school students for careers in education. This initiative supports the district's commitment to equity, accessibility, and addressing the teacher shortage. With funding from TEA's Grow Your Own grant, SMCISD will establish Career and Technical Student Organizations (CTSOs) at both middle schools, introducing students to teaching pathways early. By connecting them to the Texas Association of Future Educators (TAFE), the district hopes to increase enrollment in the high school Teaching and Training Program. This effort will help recruit, train, and retain a diverse group of future educators dedicated to serving their local schools.

The Teaching and Training Teacher (Existing) mentors students, providing resources for TAFE meetings, practices, and contests.

At the middle school level, the TAFE Sponsors (Proposed) will recruit students, prepare them for competitions, and coordinate experiences with Teaching and Training teacher.

Together, this team fosters a strong pipeline of future educators, inspiring and equipping students to pursue careers in teaching.

The primary goal of this program is to increase the number of students selecting the San Marcos CISD Teaching and Training Program of Study by establishing Texas Association of Future Educators (TAFE) chapters at both middle schools. This initiative directly supports the district's commitment to growing its own teacher pipeline by fostering early interest in education careers and providing students with meaningful learning experiences.

Activities and Strategies:

To achieve this goal, SMCISD will implement the following strategies:

1. Establish a TAFE Sponsor at Each Middle School.

Identify and designate a teacher at each middle school to serve as the TAFE sponsor, responsible for recruitment, mentorship, and program coordination. Provide sponsors with training and resources to ensure successful program implementation.

2. Recruit Middle School Students Interested in Education Careers.

Conduct outreach efforts, including presentations, informational sessions, and promotional materials, to engage students interested in teaching, coaching, or educational leadership.

Leverage partnerships with high school Teaching and Training students to mentor and inspire middle school participants.

3. Offer Hands-On Experiences and Learning Opportunities.

Provide students with access to field trips, guest speakers, and hands-on teaching experiences through both the middle school TAFE chapters and the high school Teaching and Training Program of Study.

Talent Management Strategy: Recruitment, Hiring, and Retention

SMCISD is committed to growing a diverse, skilled educator workforce by developing talent from within the community. Early exposure to teaching careers strengthens the district's pipeline and encourages students to return as future educators.

Recruitment: Expanding the Teaching and Training Program through middle school TAFE increases the number of students pursuing education degrees. Hiring: Partnerships with colleges and universities help track and support former students, creating clear pathways for them to return as teachers. Retention: Early engagement fosters a strong connection to the district, increasing long-term teacher retention.

These efforts support a sustainable pipeline of well-prepared educators for SMCISD.

The funds allocated to this project will be used to establish TAFE programs at each middle school and support the existing high school TAFE program. At the middle school level, the funds will cover the creation of TAFE infrastructure, including recruiting teacher sponsors and providing student activities and competitions. At the high school, the funds will enhance current TAFE offerings, supporting resources, mentorship, and competitive opportunities and support the T&E teacher stipend. This will create a continuous pathway for students from middle school to high school, fostering a strong pipeline of future educators for the district.


