The proposed grant activities aim to address the needs of homeless children and unaccompanied youth while promoting equitable access to essential services for improved academic outcomes. The district will provide resources like hygiene products, school supplies, clothing, and food through direct school-based programs. To support these goals, the district and campuses will conduct needs assessments, allocate funds efficiently and collaborate with stakeholders. Monitoring progress through metrics like student engagement and academic performance will ensure effectiveness. Ultimately, we anticipate increased access to resources, improved attendance, and better academic engagement among homeless students.

A.) Hempstead ISD's plan for coordinating services to support eligible homeless children and unaccompanied youth using Title I, Part A Homeless Reservations involves a comprehensive process. This includes regular review and development of the district's plan in alignment with federal guidelines and state regulations. For the 2023-2024 academic year, the planned reservation is \$1000.

B.) Hempstead ISD determines it's reservation amount for services to support homeless children and unaccompanied youth through a thorough assessment of student needs, program effectiveness, and available resources. This process involves analyzing data on the number and needs of homeless students, evaluating the impact of existing support services, and collaborating with community partners. Additionally, the district provides training and support to staff to ensure they understand district policies and procedures for supporting homeless students on all campuses, regardless of Title I status. These funds are integrated into the district's overall plan for improving educational outcomes and are reflected in campus improvement plans to address the specific needs of homeless children and youth.

Hempstead ISD conducts biannual, McKinney-Vento training sessions for all staff, facilitated by internal trainers, for enrollment, challenges, classroom strategies, resources, and reporting. Attendees evaluate sessions for feedback, informing future training. Ongoing support and resources are provided throughout the year.
