Additional grant activities that support positive education outcomes of homeless will include supplemental education activities and ensure summer learning programs.

Temple ISD will coordinateTECHY and Title I services provided to students experiencing homelessness. The district reserved \$13,000 for students experiencing homelessness in 2022-2023 and has reserved \$13,000 for 2023-2024. A percent of the overall Title I allocation is reserved for this purpose based on the number of homeless students in the district overall and the number of homeless students enrolled at non-Title I served campuses.

Training is provided annually and as needed for each campus homeless liason regarding the policies and procedures for identification and services for students experiencing homelessness. Strategies addressing the needs of homeless students are included in the 2024-2025 district and campus plans.

Systems have been developed to ensure communication and coordination between district and campus personnel and services and with students and their families. Student residency situations are reviewed periodically through the school year.

The district implements outreach programs to identify students who are not enrolled or attending school. Additionally, the district conducts community outreach to identify students who may qualify for early childhood and pre-kindergarten programs.

Accountability and Leadership Solutions provides Homeless Education Program (HEP) supports and services to traditional districts and charter districts in meeting requirements of the McKinney-Vento Homeless Education Program (HEP). All Texas public schools, charter schools, and education services centers, collectively known as local education agencies (LEAs), must follow federal rules concerning the education of homeless students. These requirements are detailed in the McKinney-Vento Act.

Professional development workshops are designed to facilitate the implementation of the McKinney-Vento Homeless Act in coordination with the Texas Homeless Education Office (THEO) to facilitate collaboration between schools and community agencies and to provide access to state and national experts in the area of homeless education.

Workshops and training will start June 1, 2024 and continue throughout 2025.
