1. ADSY Program Design: Why does the district want to join the Additional Days School Year (ADSY) Planning and Execution Program? Please specify whether the district is applying as a Voluntary Summer Learning Cohort or a Full Year Redesign district.

East Central ISD (ECISD) is applying in effort to be considered as a Voluntary Summer Learning Academy Cohort and for the mere purpose of ensuring a highly impactful Summer 2021 implementation. During the past four years, ECISD has purposefully been redesigning its entire summer program into a multifaceted, comprehensive K-12 voluntary summer program, called SUMMER@ECISD (S@E). S@E has been expanding its menu of highly engaging learning opportunities for families from across the district and evidence has shown that the district has successfully branded the program as not only an exceptional, but an expected staple of support and services to our community.

When S@E came into existence and like that of the Additional Days School Year's Voluntary Summer Program, providing equity, well-rounded enriching experiences, and supporting the district's efforts to counter summer slide were priority. In addition, ECISD unified its summer offering into one system under the S@E umbrella and created a district wide collaborative team with wrap-around services to guide and strategically design itself to efficiently and effectively service a wide range of audiences, including those not enrolled within ECISD's system and living in ECISD's surrounding areas. All these pursued efforts beautifully mirror the ADSY Voluntary Summer Learning Academy's vision, high yielding aspects, and specified program expectations

There are areas of the ADSY's Voluntary Summer Learning Academy program for which differ with ECISD's current S@E programming and appeals to the district's interest in being selected. First, ECISD values having mutually beneficial partnerships and is highly intrigued with what menu of reputable third-party vendors/resources could be choreographed specifically into S@E's Academic/Bridge programming. And even though current data shows S@E's Academic/Bridge programs serving Kinder thru 5th grade voluntary are successfully countering summer slide, only about ten percent each summer from the district's overall population are benefitting. East Central therefore views ADSY as the potential means to purposefully eliminate access barriers, enrich and accelerate the learning experiences of students.

2. ADSY Program Design: Describe the type of programming the district anticipates implementing as a part of the ADSY Program. East Central ISD's SUMMER@ECISD (S@EC) for the past four years has had a two to four-week, districtwide voluntary summer offering for incoming Kindergarten through 5th grade students called Superstar Camp. The camp is made available, on a first come first registered basis, to any of ECISD enrolled student, including Dual Language and other specialized serviced students. Annually, this full-day program (7.5 hrs.) is designed to serve 360 students by a staff of 36 content teachers, 1 special enrichment teacher, ten paraprofessionals, 2-4 summer student interns, a nurse, secretary, and a SUMMER@ECISD Coordinator. The staff are selected through an early spring vetting application process and assigned student populations aligned to their credentials, school year assignment and years of experience. In addition, the instructional staff under the supervision of the S@E Coordinator and district level S@E Director are tasked with creating and ensuring that Superstar campers are delivered high yielding, well-rounded instruction that encompasses enriched, extended learning opportunities on and off site, art exploration and the ability for their students to strategically receive scaffolded reinforcement on previously taught skills that the district's data showed as systemic deficiencies. Examples include, but not limited to social/emotional development, phonemic awareness, fluency, expository writing, math facts, math reasoning, and reading comprehension.

East Central's S@EC leaders, with ADSY's third party partners and resources, anticipates to merely replicate a similar version of Superstar Camp and host it specifically for Tier 2 and Tier 3 (bottom 15%) students from ECISD's three lowest performing elementary schools, Harmony Highland Forest, and Pecan Valley Elementary. East Central will ensure this new full-day (6+ hrs.) kindergarten to fifth grade program is designed to efficiently and effectively provide wrap around services (Child Nutrition & Transportation) for at least 7-weeks (28 days), meets the daily 180 minutes of literacy and math requirements, fosters an enriching environment, and ensures that each student receives their core instruction from vetted ECISD teachers who are applicably certified, possess the experience of teaching at their grade level, and deemed highly effective in academically growing students.

3. ADSY Program Design: Describe any prior experience with summer learning programs, extended learning time, or large change management initiatives within the district and include any relevant takeaways from implementing those programs that will be helpful in the implementation of ADSY.

East Central ISD's Superstar Camp originated from needs written six years ago into the district's Texas School Homeless Education Program (TEXSHEP) grant application. The idea was to provide twelve days of a summer enrichment program solely for second and third grade McKinney-Vento students. The majority of these students were not readers and had a variety of social as well as emotional behaviors hindering their academic development. After a very successful and highly engaging summer, the East Central community, summer teachers, campus leaders and district level administrators, including ECISD's newly appointed Superintendent of Schools, Mr. Roland Toscano, were asking, "Why is this full-day program with small student to teacher ratios, thematically designed units, and purposefully crafted on- and off-site excursions to extend learning and vocabulary development not offered to ALL?" And from this probing question, many others evolved and quickly shifted the district to strategically designing not only a way to expand the Superstar experience in the most equitable manner, but choreograph a comprehensive K-12, organizational system for all East Central ISD summer offerings to maneuver with autonomy while maximizing opportunities for the community. Over the course of the years, the systemically aligned efforts and reflective practice have grown into a habit for the district and branded SUMMER@ECISD (S@EC) as "The Place You Want To Be!" S@EC 2019 reached the highest numbe ever served with 2,285 registered participants.

East Central has grown itself through the years with implementing summer learning programs. S@EC leaders recognize the impact transitioning all aspects under an unified umbrella has had on the youth and its campuses, spread out over 270 square miles of rural, urban, and suburban communities and like TEA and ADSY, East Central ISD comprehends summer programming in general will always have physical, fiscal, and operational challenges. The main lessons learned are to listen, persist, pivot when needed, find value adding partners and ensure one's vital systemic support branches consistently and concurrently work together from the first day to the last day of the program. For instance, it is essential for S@EC student enrichment, sports, assessment, academic, and bridging programs to have timely wrap-around service support from the district's finance department, transportation department, health services, custodial and Child Nutrition's summer breakfast and lunch feeding program. Experience has shown to minimize communication breakdown and increase access, a S@EC Coordinator, secretary, and nurse are essential staff assignments for every site. To be energy efficient, cost share and respectful of summer maintenance schedules, the best practice is to strategically schedule as many offerings that may reasonably and appropriately be coordinated together on two to three campuses versus opening any of ECISD remaining campuses.

The current model of SUMMER@ECISD's K-5th grade Superstar Camp was designed with East Central ISD, Superintendent of Schools, Mr. Toscano's vision in mind. His goals for the summer programs included maximizing resources, providing a variety of highly engaging summer learning opportunities and removing barriers for access to the program. Our Federal Grants Director has consistently coordinated with our Directors of Bilingual Education and Special Education as well as Campus Principals and Pupil Service Departments to design and deliver a comprehensive program that meets the needs of our students, parents, staff, and community shareholders. Leaders serving in East Central's wrap-around services, such as library services, child nutrition and transportation, show their commitment through a variety of outreach efforts such as summer book check out, interactive performances with free book giveaways, free breakfast and lunch service as well as transportation to and from summer programs and enrichment excursions.

Collaboration of approved funding streams such as Title I, State Compensatory Education, and East Central Foundation Grant funds, have currently provided 16 days of summer instruction that the East Central community has become accustomed to annually having the opportunity to participate in. East Central's Administrative Council and it's SUMMER@ECISD program desires to offer a more rigorous program that will meet the specific academic and social emotional needs of the district's most struggling learners through increased opportunities for more students.

5. Commitment and Intent from Leadership: What components of the Planning and Execution requirements does the district believe will be most helpful in leading to a successful program and why?

East Central's participation in the Voluntary Summer Learning Cohort will allow for improvement and expansion of our existing K-5th Grade Superstar Camp, as well as offer an effective launch of the summer learning opportunities East Central ISD provides. Through a partnership with TEA and the third party vendors, the Steering Committee will begin designing the Strategic Plan, Part 1 in the Fall of 2020. Beginning the planning early in the school year will reduce logistical problems and increase instructional time for students during the summer weeks. The steering committee will have sufficient representation of staff responsible for overseeing the various responsibilities of the program and site leaders will be included in this planning. Working with external vendors will give our committee a different perspective on the approach we have taken for the last few years in offering summer learning and help increase student growth through a focused program, designed to meet the academic, social and emotional needs of our students. The access to high quality, research-based, commercially available curriculum will free up teachers from having to design the curriculum to focus on differentiating the content for each student and the delivering of the fun, engaging curriculum.

The 2019-2020 school year was inaugural year for Harmony Elementary, Highland Forest Elementary and Pecan Valley Elementary as prekindergarten to 5th grade campuses. Prior to this year, each campus had the grade span of kindergarten to 3rd grade and historically struggling to meet state and federal accountability requirements. In fact, one or more of them at a time for the last three years have publicly held the classification as a "Improvement Required" campus and been required to submit Targeted Improvement Plans to the Texas Education Agency, School Improvement Division. Furthermore all three of these campuses are Title I, part A schoolwide served and carry the three highest economically disadvantaged percentages of the entire district.

In an effort to substantially increase student achievement across the district and make a cohesive effort towards changing the accountability trajectory for Harmony, Highland Forest, and Pecan Valley, the district's Administrative Council, SUMMER@ECISD program leads, and campus principals made the collective decision to officially apply as a district to be considered in the selection process of becoming ADSY's Voluntary Summer Learning Academy Cohort participants. And since East Central's SUMMER@ECISD leaders have significant experience with implementing a model similar to ADSY's, choreographing an extended version with a strategic planning team in place and third party partners as well as resources for each campus's Tier 2 and Tier 3 (bottom 15%) students is definitely worth pursuing.

7. Pilot Approach and Campus Selection: What problem is the district/school attempting to solve by launching the ADSY Program and how does additional days help solve the root cause of the problem? Please specify by school as needed.

Harmony Elementary, Highland Forest Elementary and Pecan Valley campuses, selected to participate in the Voluntary Summer Learning Cohort, experience summer learning loss, consistent with the research, as evident in the Beginning of Year results of the MAP Reading and Math Screeners. With being identified as the district's three highest economically disadvantaged campuses (Harmony 76%, Highland Forest 74%, Pecan Valley 83%), the likelihood of this trend continuing is almost definite without intervention of increased high-quality academic opportunities during times when school is not in session. East Central Curriculum & Instruction Department and campus leadership teams know that an average student might lose an average of one month in their learning. Offering additional instructional days to our lowest performing students during the summer will address the increased likelihood of summer learning loss and give students a better chance of beginning the school year closer to grade level.

All three of the identified schools experience summer slide as illustrated in the data listed below:

A person with prior experience successfully leading these things, including any summer programming on a campus or within the district, would be an excellent candidate. Our selection for project manager is Mrs. Irma Jean Gaona, District Early Childhood Coordinator and Curriculum Support, who has been a campus academic facilitator, assistant principal and principal within East Central ISD. Mrs. Gaona has served the East Central community for over twenty years and is familiar with the district's Kinder through 5th grade support services, beliefs, values, community trends, and history; Thus, she possesses the skills and the visionary capacity to manage a project implementation of this specificity, size and scope. Furthermore, Mrs. Gaona is already an established team member of East Central ISD Curriculum & Instruction Department and has the direct responsibility of overseeing East Central's SUMMER@ECISD programming, which makes Mrs. Gaona the exceptional choice as it's Additional Days School Year's Voluntary Summer Learning Academy Cohort's project manager.

East Central's defined ADSY Project Manager, Mrs. Irma Jean Gaona, is already directly affiliated with the Curriculum & Instruction Department and reports directly to the Executive Director of Curriculum & Instruction as the Coordinator of Early Childhood and Curriculum Support. Her office is also housed with the majority of the other East Central ISD's Curriculum & Instruction staff and has physical proximity, as needed, for any essential cross-division support and timely access to the Accountability & School Transformation Department, Elementary Instructional Specialists, Federal Programs Department, and the Special Education Department. In addition, the Curriculum & Instruction Department has established routine, weekly meetings where all its sub-department leaders report on the state of their office's work and collaborate on any cross departmental priorities; Project Manager, Mrs. Gaona will be expected to join and participate accordingly. To provide Project Manager, Mrs. Gaona, with more support, data reports, and deeper level of the district and ADSY campus needs, there will be pre-scheduled weekly meetings with the Executive Director of Curriculum & Instruction and the Coordinator of Curriculum & Instruction. It is at these meetings where individual campus needs and student performance patterns are to be transparently provided as a means to enhance or pivot programming recommendations, define curriculum necessities, and plan accordingly to ensure a successful Summer 2021 implementation. All pertinent information will be reported to the ADSY Steering Committee.
